SUBJECT: Approval of Canvass of Votes for the June 6, 1989 Special
Municipal Election

SUMMARY

The official results of the Special Municipal Election for Measure M regarding the uniformity of the retirement system for safety employees are included in the attached resolution and Certificate of Facts.

BACKGROUND

Pursuant to Section 62.8 of the Sacramento City Code, the City Council must receive the Canvass of Votes no later than the second Tuesday after an election for approval. Because the County Registrar of Voters was unable to meet this deadline, a report was transmitted to the City Council on June 20, 1989 stating that Canvass of Votes for the Special Municipal Election conducted on June 6, 1989, would be forwarded to the City Council for the June 27, 1989 City Council meeting.

FINANCIAL DATA

Prepayment for the Special Municipal Election was deposited in the amount of \$95,285 to the Sacramento County Voter Registration and Elections. This amount was based on an estimate prior to a countywide measure that was later added to the consolidation. According to Voter Registration and Elections, the actual cost of the election was \$78,523.44, therefore, a refund in the amount of \$16,761.56 is forthcoming from the County.

NOW, THEREFORE, BE IT RESOLVED that the Council does declare the said Special Municipal Election was duly and regularly held and conducted on June 6, 1989, and the City Clerk of the City of Sacramento did duly and regularly cause to be canvassed the vote of said election, and reported the result of said canvass to the City of Sacramento as follows:

MEASURE M

Relating to the uniformity of the retirement system for safety employees.

Shall the Charter of the City of Sacramento be amended to permit the transfer of active safety employees who are currently members of the Sacramento City Employees' Retirement System to the Public Employees' Retirement System (PERS) in order to provide equitable treatment for the transferred safety employees?
