## Attachment A

- A. SACRAMENTO DISABILITIES ADVISORY COMMISSION to fill three (3) positions. This opening represents all term expirations; one (1) in May and two (2) in July 2005. Members are appointed by the Mayor and approved by the City Council, and shall be residents of the City of Sacramento.

OPEN APPLICATION PERIOD 07-22-05; APPLICATIONS DUE 08-26-05.

- B. COMMUNITY RACIAL PROFILING COMMISSION to fill three (3) positions. This opening represents all three (3) seats where appointees resigned prior to their term expirations; two (2) in November 2006 and one (1) in November 2007. One (1) appointee shall be a resident of, and recommended for appointment by council district 1. Two (2) appointees shall be from the public-at-large, qualified by interest or experience on matters pertaining to racially biased policing. All appointees shall be residents of the City of Sacramento, appointed by the Mayor and approved by the City Council.

OPEN APPLICATION PERIOD 07-22-05; APPLICATIONS DUE 08-26-05.

- C. ANIMAL CARE SERVICES CITIZENS ADVISORY COMMITTEE to fill two (2) positions. This opening represents one (1) seat with a term expiration in April 2005 and one (1) seat where the appointee resigned prior to the term expiration in April 2007.
