### SUMMARY

SUBJECT: CIP Project Addition and Status Report - Arcade Creek Levee Extension  
(PN: WA91) and 1986 Floodgates (JN: 7920)

### SUMMARY

Special procedures are being used to expedite construction of the Arcade Creek Levee Extension at Hagginwood Park and the construction of floodgates at four sites. Planned construction completion is October 15, 1986. It is requested that the 1986 Floodgates project be added to the CIP Program and that a fund transfer be approved. This item was considered by the Budget and Finance Committee at its meeting of August 14, 1986.

### BACKGROUND

The Department of Public Works is expediting the design and construction of several flood control projects to minimize the risk of a recurrence of major flooding like that which the City experienced in February's record setting storms.

The first project is the repair and strengthening of the Beach Lake Levee. This contract was awarded July 29, 1986 and the work should start soon.

The second project is the Arcade Creek Levee at Hagginwood Park (PN: WA91). Funded this fiscal year, the project will be built in two stages. The first phase is the immediate construction of a levee varying in height from five feet to one foot. The second phase will reconstruct the park improvements. The levee design and the park restoration have been coordinated with the Department of Parks and Community Services.

The third project, 1986 Floodgates, will construct removable floodgates at four sites. The sites are the Natomas East Main Drain at Main Avenue, Union Pacific Railroad at Arcade Creek, Union Pacific Railroad at Dry Creek, and Rio Linda Boulevard at Arcade Creek. The floodgates on Rio Linda will not be needed when the Rio Linda Boulevard bridge is reconstructed next year. The gate components will then be used as reserve parts for the other three sites. This project is not currently funded, and is not included in the CIP Program. It is requested that this project be added to the CIP Program and that \$240,000 be transferred from the Reconstruction of the South Side American River Levee project (PN:WA96). This project is being funded and constructed by the American River Flood Control District and the Corps of Engineers, not by the City.


FINANCIAL
