June 29, 1970

A meeting of the Governing Board of Sacramento Community Center Authority was held at the City Hall, Sacramento, on June 29, 1970, at the hour of 4:45 o'clock p. m., of said day, pursuant to notice received by all members of the Governing Board, fixing the time and place of meeting.

Directors present: George W. Artz, Vincent M. Caselli, and Alfred W. Riolo, Alternate..

Directors absent: Walter Christensen, David C. Rust, Tony Westra, and Ed Combatalade, Alternate.

Vice Chairman Artz called the meeting to order at 4:45 o'clock p. m.

Upon motion duly made, seconded and unanimously carried, the minutes of the meeting of June 15, 1970, were approved.

Authority Controller, Cortez A. Kitchen and Assistant City Controller, C. E. Rhodes, were present and the Authority Controller submitted Community Center Authority Statement of Revenue and disbursements, July 1, 1969 through May 31, 1970, which was discussed and ordered filed.

Director Caselli reported concerning plans and drawings for proposed theater.

Director Rust arrived.

Vice Chairman Artz stating that it was time to seriously consider some sort of memorial program and Director Rust questioning, the legality of solicitation of funds before issuance of bonds, the City Attorney was requested to obtain quide lines from the Bond Counsel with regard to fund solicitations.
