The meeting was called to order at 4:05 p.m. by Chairman Terry Kastanis.

**MINUTES:**

Diane Balter, Deputy City Attorney, gave a summary of this ordinance relating to pay telephones which was developed at the request of Councilmember Lynn Robie. Robie presented her objective to remove pay telephones which constitute a public nuisance. Kastanis agreed this should go before the Council and the vendor representatives be notified for the first meeting in December. Robie moved to recommend this proposed ordinance to full Council. Kastanis seconded the motion.

**2. An Ordinance Adding Section 66.209 of the Sacramento City Code Authorizing the Police Department to Recover Costs for Multiple Responses to Loud Parties.**

**MINUTES:**

Captain George from the Sacramento Police Department spoke in favor of the loud party ordinance. Diane Balter, Deputy City Attorney, commented that the City of Santa Clara found the ordinance to be effective. Kastanis would like the City Attorney's office to report back to the Committee on the effect this ordinance has had on the City of Santa Clara over the next six months. Robie moved to support this proposed ordinance. Kastanis seconded the motion, and the loud party ordinance was supported.

**3. An Ordinance Amending Articles I (Sections 9.01 through 9.72 only), III, IV, V and VI of Chapter 9 and Repealing Article II of Chapter 9 of the Sacramento City Code Pertaining to the Adoption of the 1988 Edition of the Uniform Building Code, Uniform Plumbing Code, Uniform Mechanical Code and the 1987 Edition of the National Electrical Code.**

**MINUTES:**

Tim Sullivan, Building Inspections Manager, summarized that the proposed ordinance was presented at this time for revision and updating of the City's building, mechanical, plumbing, and electrical codes. He related that the proposed code revisions had been reviewed by the construction industry and that their suggestions had been accommodated. Robie moved that this ordinance be supported and forwarded to Council. Kastanis seconded the motion and the proposed ordinance was supported.

**ADDITIONAL ITEMS/DISCUSSION:**

Robie discussed the proposed Alcohol Tax initiative. She reported she had met with Assemblymember Lloyd Connelly and had encouraged that they allow the tax revenues to be used to monitor residential care facilities. Language permitting use of funds received by the police for that purpose reportedly was added to the initiative. The Committee requested that staff bring the Alcohol Tax initiative to the Council.


