## MINUTES

Reginald Young, Deputy Director, Public Works Administration, reviewed this item. He urged approval of an expanded model of exemptions similar to those in use in other communities. Sacramento currently does not require a physician's verification of a disability, resulting in many more exemptions than are experienced in other communities. The new standards would require a physician's verification of disability which would be checked by the City annually. People who couldn't afford to go to a private physician for their verification could go to UC Med Center on Stockton Boulevard.

If approved by the City Council, these revised standards would become effective July 1, 1991.

Council member Pane asked how many complaints of abuse there had been. Mr. Young responded that there had been over 1,000 in the last year. Several citizens came before the committee presenting a strong "neighbor complaint" of a specific abuse, and staff was directed by Council member Serna to verify the disability of the individual in question.

Council member Fargo MOVED, Council member Pane SECONDED, forward by CONSENT.

Robert Thomas, Director of Parks and Community Services reviewed this item.


Staff recommends that park sites be given permanent names as soon as possible after purchase; that they be named after a school if adjacent to the park; and that a naming proposal be sent to the advisory committee as soon as possible when an organization donates a park to the City.

Council member Serna asked that ethnic names receive more equitable treatment. Council member Fargo expressed concern that the parks reflect local citizenry or local geographic features. Mr. Thomas responded that the language of the policy would be changed to reflect those priorities in the staff report to Council.


Council member Fargo MOVED, Pane SECONDED, forward by CONSENT.
