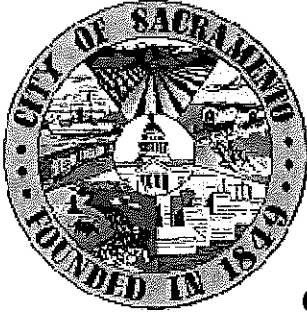

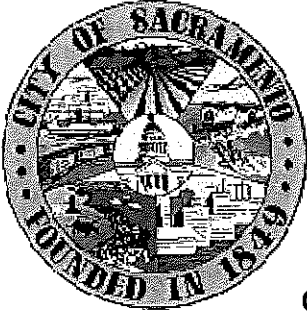

## Senate Constitutional Amendment 10 Three Day in Print Rule *By Senator Lois Wolk*

### Summary

SCA 10 would require all legislation, except emergency legislation, to be in print and online for 72 hours prior to final passage by the Senate or Assembly. The SCA also would modify the 30-day in print rule to allow policy committees to review bills after they have been in print and online for at least 15 days.

### Background

In the last two-year session, the Senate and Assembly considered nearly 5,000 legislative proposals. Hundreds of those became new laws, from the obscure to the significant. While most of those proposals were publically shared and well-vetted, some were not. Last-minute changes to bills can leave legislators unsure of what they are voting on – and prevent the public from weighing in on proposals.

To address this challenge, SCA 10 would amend the state Constitution to require all legislation, including the state budget, to be in print and publicly available for at least 72 hours before final passage by either house. Only bills required to respond to a state of emergency declared by the Governor would be exempt from this requirement. SCA 10 also specifies that legislative committees could begin the work of reviewing bills after 15 days, rather than the current 30-day requirement, but only if the language to be considered is both in print and posted online. This change would ensure that the public has an opportunity to read newly proposed laws while permitting the Legislature to get to work on bills earlier in the legislative session.

SCA 10 balances the need for public access to proposed legislation while maintaining sufficient flexibility for the Legislature to do its work. The Legislature has put in place a similar requirement for local governments, including the need to wait five days between amending an ordinance and its adoption. That requirement dates back to at least 1883. The State also can wait a few days to make sure the public has a chance to read proposed legislation before it is adopted.

### This Constitutional Amendment:

- Enhances legislative accountability.
- Ensures public access to new legislation and recently amended legislation.
- Provides flexibility during times of natural disaster, other emergencies or crises.
- Authorizes the Legislature to get to work more quickly on newly proposed laws.
