SUBJECT: Extending Time on Contract for Improvement Proceeding No. M-4818, Oak Park Street Lighting Assessment District

BACKGROUND INFORMATION

The Council awarded a contract to Collins Electrical Co. Inc. on October 10th, 1978 for constructing a street lighting system in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for July 26th, 1978. Since that time, two extensions of time have been granted by the Council making the current completion date December 21st, 1979. The work is completed but the assessment must be spread.

RECOMMENDATION

It is recommended therefore, that the Council grant an extension of thirty days to Collins Electrical Co. Inc. by adoption of the attached Resolution Extending Time on Contract.
