9. Oak Park Community Center Expansion Update and Schematic Design Presentation

Dave Mitchell, Operations Manager, Jeff Blanton, Associate Architect, General Services Department, and Matt Hertel, Sacramento Housing and Redevelopment Agency, reviewed the project scope and preliminary plans, timeline and public review process, including realignment of 9th Avenue and a new plaza. The project plans include removal of heritage trees and planting new trees as part of the project. Staff confirmed the trees would be noticed and subject to review under the City Code regarding heritage trees.

10. Amendment to City's Telecommunications Policy and Fee Schedule

Mary deBeauvieres, Principal Planner, and Bill Sinclair, Real Estate and Asset Manager, General Services Department, reviewed the item. Staff and commissioners discussed proposed revenue changes, City property leasing vs. permitting, input from telecommunications companies, how locations for new equipment are determined,

public notification processes for proposed sites, and how current and abandoned sites are managed.

Action: Moved, seconded and carried to: support the proposed amendment to the City of Sacramento's telecommunications policy and fee schedule; recommend to the Planning Commission to consider increasing the notification radius for new sites from 500 feet to 2500 feet and notice park permittees should the proposed site be in a City park, and keep lease revenues within the City planning area. 11. Private Security in City Parks

Dave Mitchell, Operations Manager, reviewed the item. Commissioner Azar expressed concerns regarding adequate training and screening of security guards by private security companies. Ms. L.R. Roberts spoke to issues with smoking, drugs and unauthorized food sales in McClatchy Park.

Action: Moved, seconded and carried to support amendments to Sacramento City Code allowing access to City parks by private security guards under a permit issued by the director. Dave Mitchell, Operations Manager, and Mark Griffin, Special District Manager, Finance Department, gave an update on the project and engineering study, and City senior management's determination to postpone the study pending action by the California State Supreme Court regarding property assessment measures under Proposition 218. Commissioners and staff discussed the situation, including activities, timing, costs, other types of assessments, and the need for public outreach should a parks maintenance ballot measure move forward with the City Council.

Dave Mitchell gave the Director's Report in the absence of Jim Combs, and spoke to community garden and skate park openings.


Questions, Ideas, and Announcements of Commission Members
