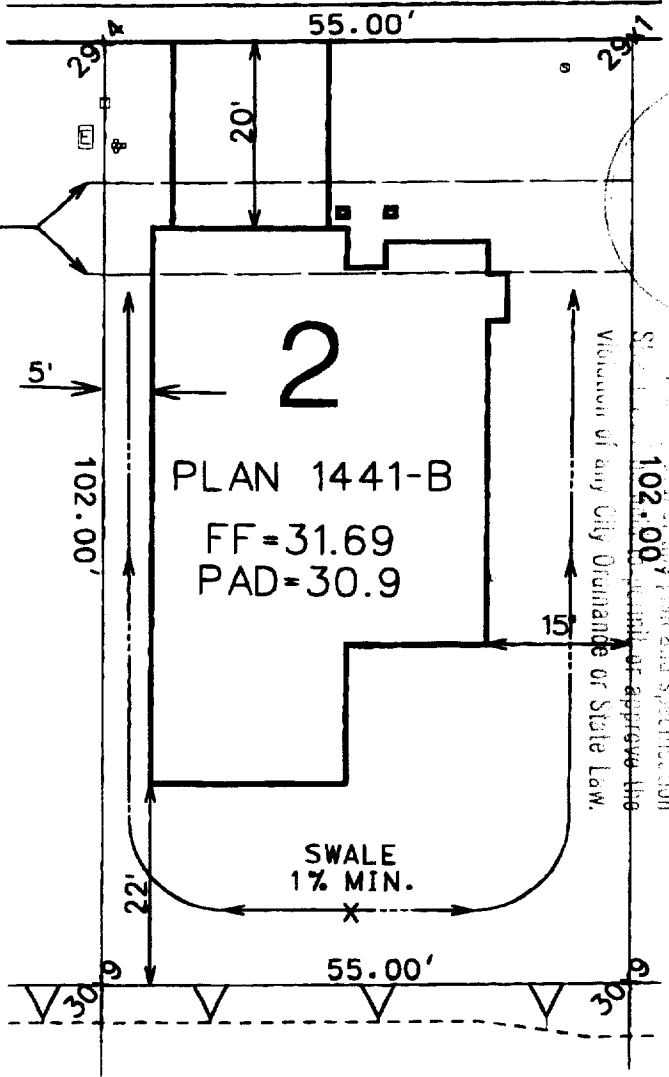

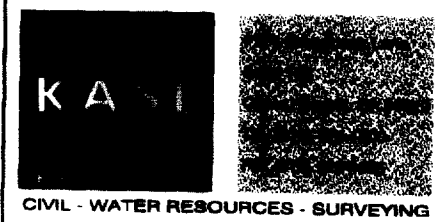
FRONT YARD VARIABLE SETBACK 15'-26'(TYP)
