

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

October 2, 1936

The Civil Service Board met in special session in the office of the Board at 8:00 P.M., President Chenu presiding.

PRESENT: Commissioner Stacy and President Chenu.  
ABSENT: Commissioner Deise.

PREVAILING WAGES  
FOR LINEMEN

Mr. H. C. Gunn, representing local Union #162, "Sheet Metal Workers", and Messrs. H. H. Stead, V. J. Horton, and

C. A. Barr appeared before the Board and informed the Board that at frequent intervals Electricians had been employed for outside Lineman work for short periods of time at the rate of \$10.00 per day. The Secretary presented to the Board information secured from local Utility companies and from the City records indicating that Utility Companies paid an average of \$175.70 per month, which rate included allowances for vacations and sick leave. After averaging the rate paid by Utility Companies with that as paid by the City and including the allowances as made by the City for sick leave and vacations, the average amounted to \$9.56 per day, whereas the average of Utility Companies only, amounted to \$8.02 per day.

After discussion, the Board requested the Secretary to advise the Council of its findings in accordance with the Council's request of October 1, 1936.

LABORER'S ELIGIBLE LIST #83

The Secretary presented notices of certification for the position of Laborer dated June 23, 1936 and August 31, 1936 together with a request as made by Mr. Stephenson that his name be returned to the Laborer's Eligible Register #83. Mr. Stephenson had stated that he had moved from the address as shown and that people living at his former address had failed to forward the notices. After discussion, the Board ordered that his name should not be returned to this Eligible Register.

The Secretary advised the Board that Mr. Athanassiou's name had been removed from the Laborer's Eligible Register #83 because he had been found incapacitated for the performance of his duties by the City Physician some months ago. Mr. Athanassiou was re-examined by the City Physician September 30, 1936, and was found to have overcome his former disability. After review of the physical report dated September 30, 1936, the Board ordered that his name be returned to the Eligible Register.

CUNNINGHAM, ELMER

Mr. Cunningham, who has been appointed from the Truck Driver's

List, requested information as to whether or not he has had six months service as a Truck Driver. After review of his record and a determination he has accumulated more than six months during his last fiscal year, the Board ordered that he be informed that he has completed more than six months employment and hence would not have to take the new Truck Drivers' Examination #95.
