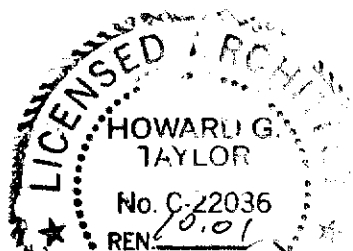

We changed the shear wall layout as follows:

Braced wall layout, page A2, wall line A, showed (2) 32" legs w/ 4" nailing. The window is being deleted allowing for a 48" panel next to the door in the corner. The load imposed on this leg is minor, 245# LF and easily accommodated by the 48" panel.
