SUBJECT: Sacramento Metropolitan Arts Commission/Contract with
artist Roger Berry for artwork for Civic Center Garage,
Art in Public Places program

SUMMARY

This report recommends that Budget and Finance Committee: 1) approve the attached contract between the City and artist Roger Berry in the amount of \$25,000 for artwork for the Civic Center Garage; 2) Authorize the City Manager to execute the agreement; and 3) Forward this report to City Council with recommendation for approval.

BACKGROUND

The Sacramento Metropolitan Arts Commission held a competition for an artist to develop an arts program for the Civic Center Garage. Roger Berry was the artist selected for the commission. The City entered into a contract with Roger Berry for \$10,000 for development of an arts plan. This second contract is for the completion of the arts plan for a total amount of compensation not to exceed twenty-five thousand dollars (\$25,000).

On June 15, 1989 the Art in Public Places Committee recommended the artwork of Mr. Berry and the Sacramento Metropolitan Arts Commission subsequently approved it on July 12, 1989. The artwork will consist of a fine sheet of water cascading over the northwest corner of the garage and a handsculpted granite column and catch basin. The water will be channeled to run down the granite sculptural column and into a catch basin and be recycled.

FINANCIAL DATA

The city percent for art ordinances requires that 2% of the total

construction cost of qualified capital improvement projects be utilized for artwork. These funds for the Civic Center Garage have been deposited in the Art in Public Places Trust Account.
