MINUTES

Donna L. Giles, Director of Personnel, gave a brief overview of the Affirmative Action Advisory Committee's concerns and staff's response to those concerns.

Karen Wells, Chairperson, of the Affirmative Action Advisory Committee gave a brief background of the AA Committee and its goals. She also stated that staff had done a good job considering the budget restraints they have with staffing and funds.

Councilperson Fargo asked staff if exit interviews were conducted. Ms. Giles informed her that they were not. Councilmember Fargo suggested utilizing retirees to help in recruiting minorities and women.

Ms. Giles informed the Committee that the City had tried three times to put a measure on the ballot to change the Rule of Three but it had failed all three times. She suggested that maybe we should try again since it has been seven years since the last ballot measure failed. Ms. Giles said that if the City-County Consolidation ballot measure is approved by the voters, we will no longer be bound by Rule of 3. If, however, consolidation is defeated, we will probably try to change Rule of 3 at a later election

Councilperson Mueller asked staff to report back on the feasibility of the City joining the Firefighters Joint Apprenticeship Program.

Councilperson Mueller also requested that staff prepare a report to the Budget and Finance Committee listing the cost factors for additional staff.

Eric Vega, Community Activist, addressed the Committee. Mr. Vega asked that the Council take a more active role in affirmative action goals. He asked that they be more accountable for affirmative action and that they budget more money so that these affirmative action goals can be met.

Clyde Rainwater representing the NAACP addressed the Committee. He said that he recognized the Committee's efforts and that he would like to work with staff to help them achieve their affirmative action goals.

Gloria Robertson representing Blacks in Government asked questions of the Committee and staff on behalf of Blacks in Government.


Yolanda Ortiz representing the Vietnam Veterans addressed the Committee and asked them to continue to work toward their Affirmative Action goals.

Councilman Serna informed the audience that it is important for the proponents of Affirmative Action to take a more active role themselves, to come before the City Council at their meetings and continue to talk to them about their concerns. If they do not speak up the Council will not take them as seriously as other interest groups.
