SUBJECT: Request for \$8,960.00 Amendment to City Treasurer's FY 1981-82
Operating Budget

SUMMARY

The City Treasurer is requesting an amendment to the FY 1981-82 Treasury Operating Budget in the amount of \$8,960.00 for the purpose of continuing the temporary Senior Accountant hired through Accountemps. It is estimated that the requirement for a temporary accountant will extend for approximately three and one-half months.

BACKGROUND

As reported in correspondence of May 19, 1981, a Senior Accountant on City Treasurer's staff, Russell Chinn, suffered a heart attack the early part of May and a temporary accountant was hired through Accountemps, Inc. to assist in conducting investment accounting and reporting business related to Treasury operations. Our present information is that it will be at least sometime in August before Mr. Chinn returns to the doctor for further tests as a result of complications he has recently experienced. If Mr. Chinn returns to work sometime in September or October, the possibility exists that he may be unable to work on a full-time basis. Mr. Chinn presently has approximately 80 working days of sick leave and vacation remaining. Request is therefore made to retain the temporary accountant until such time as Mr. Chinn is capable of performing his normal duties on a full-time basis.

RECOMMENDATION

It is recommended that the City Council approve the attached Resolution.
