

Sacramento, California,

March ~~16~~<sup>13</sup>, 1932.

The Civil Service Board of the City of Sacramento met in regular session on the above date at five-thirty o'clock P. M. in the office of the Board, Room 106 City Hall, President Weisman presiding.

PRESENT: Commissioners Chenu, Deise, and Weisman.

ABSENT : None.

The minutes of the previous meeting were read and approved as corrected.

At this time Mr. William E. Tingle appeared before the Board, requesting that he be granted some consideration on account of the disability which he suffered while an employee in the Waste Removal Department. The Board advised Mr. Tingle that they had no authority to place him back at work and that the award which was granted him by the Industrial Accident Commission was final so far as the Civil Service Board were concerned. Mr. Tingle advised the Board that he refused to accept the check which was drawn in his favor and that he would make an appeal to the Industrial Accident Commission for a rehearing of his case. In accordance therewith it was properly moved by Commissioner Chenu and seconded by Commissioner Deise that Mr. Tingle's request be denied. The vote was as follows:

AYES: Commissioners Chenu, Deise, and Weisman.

NOES: None.

A communication was received from the Sacramento Municipal Employees Protective and Mutual Benefit Association dated February 26th, advising the Board that no consideration be granted any person or persons acting for or representing this association unless

they produced their authority which would be in the form of a letter signed by the President and the Secretary of the Association. The communication was ordered placed on file.

At this time the removal of Mr. C. T. James, an employee in the Street Cleaning Department was presented. It was properly moved by Commissioner Chenu and seconded by Commissioner Deise that it was the opinion of the Civil Service Board, based upon the information before them and the investigation which was made by the Secretary and the Waste Removal Department, that Mr. C. T. James is employed by the City of Sacramento in violation of the Charter; he not being a resident of the city, and it was recommended that his removal from the service of the City of Sacramento be conveyed to the City Manager. The vote was as follows:

AYES: Commissioners Chenu, Deise, and Weisman.

NOES: None.

At this time the Civil Service Board adjourned to meet as a Pension Board.

At seven-thirty o'clock P. M. the Civil Service Board reconvened in regular session.

A communication was received by the Board, through Commissioner Chenu, from Mrs. Anna Schulze, 911 23rd Street, an applicant who took the examination for Junior Clerk. This applicant's examination paper was lost the day of the examination and she requested that she be reimbursed for the expense incurred by her for notary fee and the renting of a typewriting table, the amount of this being one dollar. It was properly moved by Commissioner Chenu, seconded by Commissioner Deise, that the three members, together with the Secretary, contribute twenty-five cents and that a check be mailed by the Secretary to Mrs. Schulze, reimbursing her for her expense. The vote was as follows:

AYES: Commissioners Chenu, Deise, and Weisman.  
 NOES: None.

A communication was received from Mr. Henry McFarland, Jr., Secretary-Treasurer of the Western Conference of the Civil Service Assembly, requesting that the Civil Service Board be represented at their forthcoming conference in San Francisco on August 18th, 19th, and 20th. It was properly moved by Commissioner Deise, seconded by Commissioner Chenu, that the Secretary be instructed to advise Mr. McFarland that this Board would convey to them any matters that they wished discussed after their regular meeting on March 18th. The vote was as follows:

AYES: Commissioners Chenu, Deise, and Weisman.  
 NOES: None.

The question of a transfer of Mr. Walter Henderson from the Recreation Department to the Engineering Department was discussed and the Board was advised by the Secretary that when a transfer was made by the Recreation Department to the Engineering Department that Mr. Henderson took the classification of Carpenter in the Engineering Department with the understanding and full knowledge that he still existed in the service of the City of Sacramento as a temporary employee under this classification, and was subject to an examination for Carpenter knowing that a failure to pass this examination would eliminate him from any further service with the city.

There being no further business, the Board stood adjourned at eight-five o'clock P. M. to meet again at the call of the Chair.
