

**RESOLUTION NO. 2015-0072**

Adopted by the Sacramento City Council

March 17, 2015

**FREEPORT BOULEVARD AND CLAUDIA DRIVE TRAFFIC SIGNAL PROJECT  
(T15134300)**

**BACKGROUND**

- A. This project will enhance public safety for pedestrians, bicyclists and vehicular traffic crossing Freeport Boulevard and Claudia Drive. Pedestrian crosswalks and stop bars will be placed on all legs of the intersection, and the existing driveway located at the east side of the intersection will be reconstructed to align with Claudia Drive and converted into a one-way pair of driveways. The other existing driveway located about 32 feet to the north of the intersection will be closed so that a pedestrian crosswalk will be accommodated at the north leg of the intersection.
- B. The project was advertised on January 9, 2015 and bids were received on January 28, 2015. The bids are summarized below:

- C. The Engineer's estimate is \$275,000.
- D. Construction is expected to begin in April 2015 and be completed in July 2015.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL  
RESOLVES AS FOLLOWS:**

- Section 1. That Plans and Specifications for the Freeport Boulevard and Claudia Drive Traffic Signal Project (T15134300) are approved.

- Section 2. The FY14/15 Capital Improvement Program is amended by transferring \$157,561 (Fund 2001) from the Major Street Improvement Project (T15138000) to the Freeport Boulevard and Claudia Drive Traffic Signal Project (T15134300).
- Section 3. The FY14/15 Capital Improvement Program is amended by transferring \$177,439 (Fund 2001) from the Major Street Improvement Project (T15148000) to the Freeport Boulevard and Claudia Drive Traffic Signal Project (T15134300).
- Section 4. The construction contract is awarded to Pacific Excavation for an amount not to exceed \$329,999 for the Freeport Boulevard and Claudia Drive Traffic Signal Project (T15134300).
- Section 5. The City Manager is authorized to execute a contract with Pacific Excavation for an amount not to exceed \$329,999 for the Freeport Boulevard and Claudia Drive Traffic Signal Project (T15134300).
