A YEAR OF RECORDS

Port tonnage records were smashed continually during the 1980 year. Monthly records were set several times this past year building to a new annual record of 3,257,303 tons of cargo on the ship channel in 1980. This new record surpassed the 1979 record year by nearly 50%. As would be expected in a record year such as this, the number of ship calls were also a record. 191 ships transited the channel in 1980.

ACTIVITIES OF THE FOURTH QUARTER OF 1980

Construction on the Port's \$10 million expansion program moves forward. Two of the three-phase projects that will add additional storage space, a new conveyor system, and ship loading equipment were underway in the fourth quarter. Completion of the three-phased project is expected by the end of 1981.
