

RESOLUTION NO. 2014-0001

Adopted by the Sacramento City Council

AGREEMENT: KNOWLEDGE AND INTELLIGENCE PROGRAM PROFESSIONALS

BACKGROUND

- A. In September 2013, City Council adopted Resolution 2013-0308 authorizing the Fiscal Year (FY) 2013 Urban Area Security Initiative (UASI) grant (G11011600). The purpose of the UASI grant program is to enhance the capabilities of high-risk, high-density urban areas to prevent, protect against, mitigate, respond to, and recover from acts of terrorism.
- B. As a condition of funding, 25 percent of the award must be dedicated to supporting Law Enforcement Terrorism Prevention-oriented Activities (LETPA). In order to meet this requirement, the Sacramento Police Department (SPD) is seeking approval to suspend competitive bidding requirements and enter into an agreement with Knowledge and Intelligence Program Professionals (KIPP).
- C. Under this agreement, KIPP will provide: 1) Terrorism Awareness/Fusion Center Outreach sessions; and 2) Countering Violent Extremists training courses. Terrorism Awareness/Fusion Center Outreach is a new, collaborative, training opportunity that will teach public and private sector organizations how to recognize and report potential threats to law enforcement. This training is region-specific and fulfills a National Preparedness Goal to be inclusive of both the public and private sector in terrorism awareness training. The Countering Violent Extremists course is an ongoing training opportunity for regional first responders, health officials, emergency managers, and public officials. KIPP is the only provider for this type of training and therefore the SPD recommends that the City Council suspend competitive bidding. The proposed agreement shall be in an amount not to exceed \$103,600 and will expire May 31, 2015.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1. In the best interests of the City, competitive bidding is hereby suspended for the purpose of entering into an agreement with Knowledge and Intelligence Program Professionals (KIPP).

Section 2. The City Manager, or the City Manager's designee, is authorized to enter into an agreement with KIPP in an amount not to exceed \$103,600 through May 31, 2015.
