SUBJECT: Resolution Authorizing Continuation of Operating  
Appropriations

### SUMMARY

The attached resolution authorizes the Interim Executive Director to continue to expend funds for salaries, services, and supplies applicable to the operation of the Agency's on-going programs. The grant of authority shall be in effect from 1/1/82 to 2/15/82 and shall not exceed 2/12 of the approved 1981 calendar year agency budget for major expenditure categories and Agency organizations.

### BACKGROUND

On January 20, 1981 a resolution was adopted by the Agency's Governing Boards establishing budget control principles which requires the establishment of appropriations by major expenditure categories and organizations for the control of Agency expenditures. The Agency has not had a preliminary budget approved for 1982 by the Governing bodies. Since current appropriations lapse at 12/31/81, it is necessary to establish appropriations until a 1982 preliminary budget can be adopted.

### FINANCIAL DATA

The total appropriations to be continued shall not exceed 2/12 or \$4,788,688 of the Agency's 1981 approved calendar year budget. The appropriation amount shall be expended in proportion of 2/12 the 1981 appropriations for Employee Services, Services and Supplies by Organization.


