Jim Prosser, representing the California Spa and Pool Industry Council, voiced his support of this new recommendation.

2. Ordinance amending Section 6.47 of the Sacramento City Code relating to the transportation of animals in vehicles.

Diane Balter, Deputy City Attorney, was present to answer any questions regarding this matter.

Doug Pope arrived at 4:20 p.m.

Mr. Darris Hercs of the Sacramento SPCA spoke on behalf of support for this ordinance. He presented a portfolio to the Council with 8200 citizen signatures and support letters from private citizens, the Sacramento Bee, television, etc. He stated that this ordinance was preventative, and that similar laws have been in effect elsewhere for a long time.

There was considerable discussion regarding the lack of statistics for animals or persons hurt or killed because of accidents caused by animals riding in the backs of pickup trucks. Mr. Hercs feels that even one accident involving an animal's life is one too many. He also feels that statistics are not necessary, as this is a preventive measure.


Mr. Dennis Inks from the City of Folsom spoke. He stated he has served on the Local Agency Formation Commission of Sacramento County (LAFCO) and on a transportation task force for the Sacramento Area Council of Governments (SACOG). He expressed his support of this proposed ordinance, and explained that it is like the seatbelt issue: The Police Department is not going to go around looking for people who don't wear seatbelts (or have dogs in the backs of pickups), but that if a vehicle is stopped for another violation, they will be cited for the additional infraction. Mr. Inks feels that this ordinance should be passed for the sake of public safety.

Ruben Mora of the Department of Animal Control stated that statistics from the CHP for the past three years showed only a couple of accidents caused by transporting animals in the backs of pickups, but that this report is only for freeways. He stated that transporting animals in the backs of pickups hasn't been a problem in the City, and that the City doesn't have the tools to enforce this.

Motion was made by Councilman Bradley, seconded by Councilman Pope, to approve the ordinance amending Section 6.47 of the Sacramento City Code. The motion was carried as noted above. It was noted at this time that this matter will be heard at the May 12th Council meeting, and it was requested that statistics be provided at this time, if possible.

The meeting was adjourned at 4:32 p.m.
