SUBJECT: Recommendation of Bid Award for AUTOMATIC IRRIGATION AND PLAYGROUND IMPROVEMENTS AT MAX BAER PARK

SUMMARY:

The subject project, as part of the City's Capital Improvement program, has been advertised for bids. Bids have been received and the City Engineer recommends bid award.

BACKGROUND:

On April 29, 1980, the City Council approved plans and specifications for the subject project and bids were received and opened by the City Clerk in the Council Chambers on May 20, 1980. The bids received are as follows:

Clifford C. Perini	\$118,009.50
B & V Landscaping, Inc.	118,338.50
Gus Navarrete	121,803.00
Daluis Iesiy Co., Inc.	128,126.35
Dig-It Engineering & Construction Co., Inc.	161,668.50
Cioli Landscaping, Inc.	163,748.80

FINANCIAL:

The engineer's estimate for this project was \$98,948.00. Although the low bid of Clifford C. Perini is 19.26% above the engineer's estimate, we feel it is the best bid obtainable. The Department of Community Services will be submitting a letter to Council recommending appropriation of additional funds to cover the construction cost and engineering contingencies.

RECOMMENDATION:

It is recommended that the low bid of Clifford C. Perini in the amount of \$118,009.50 be accepted.
