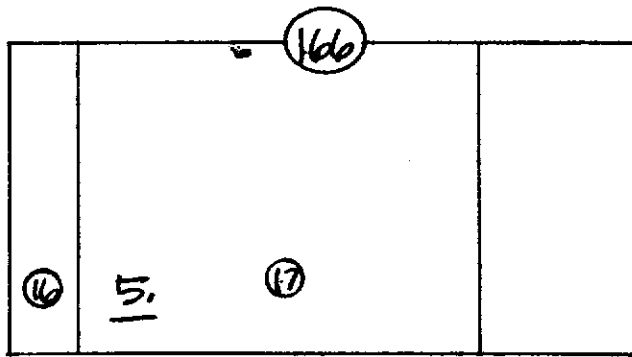

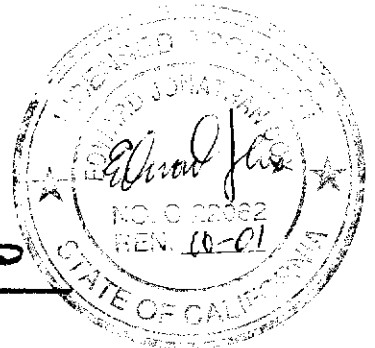
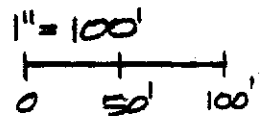


SUBJECT SITE

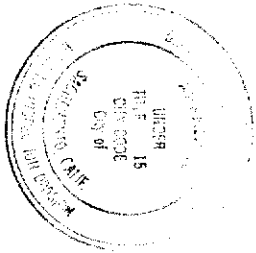

PROPERTY OWNERSHIP MAP

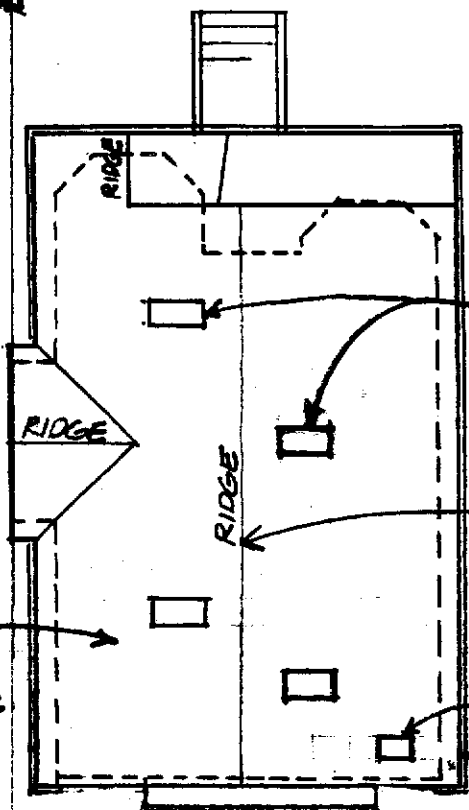

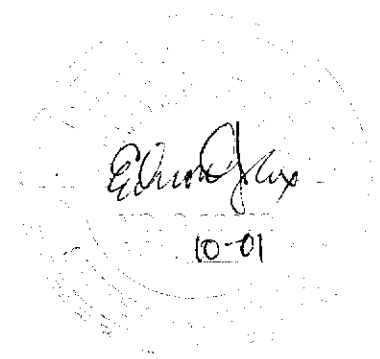

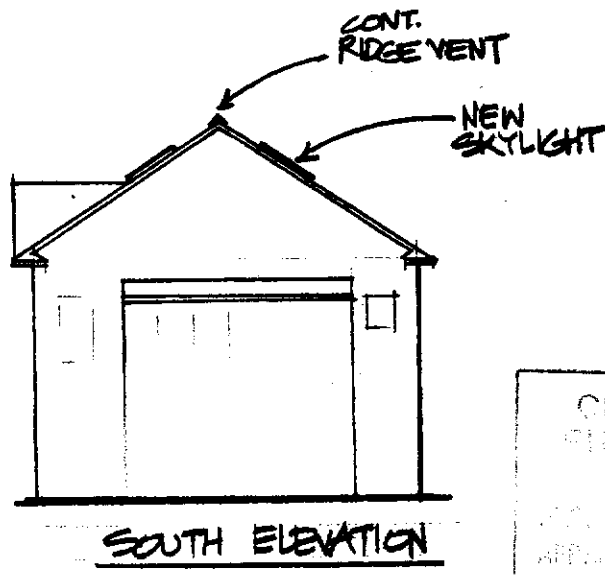


SITE/ROOF PLAN

SOUTH ELEVATION

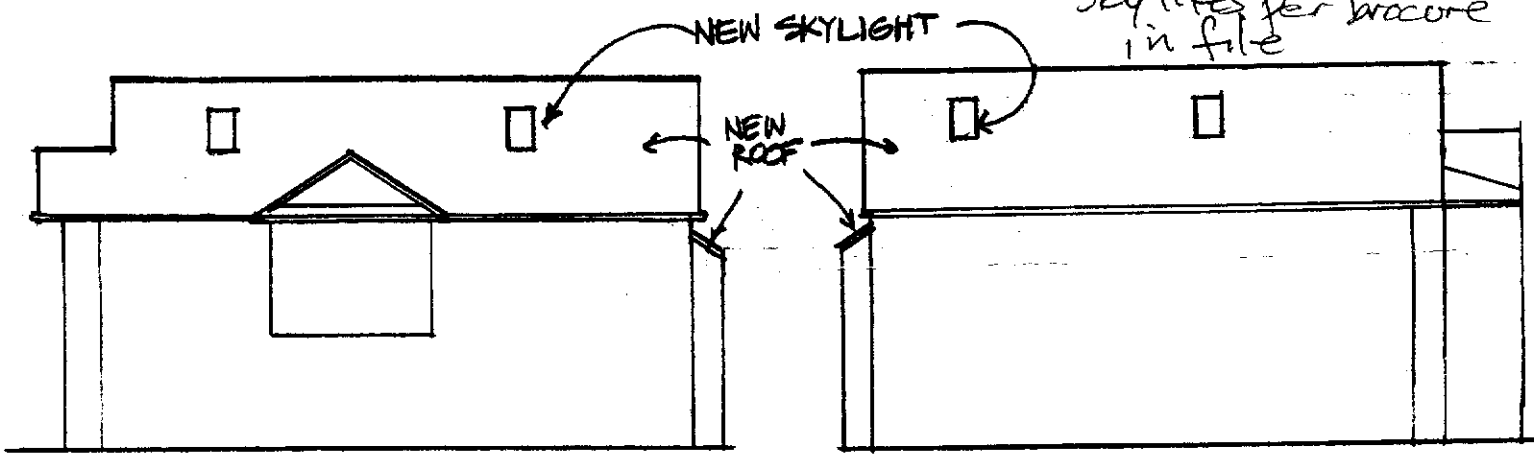

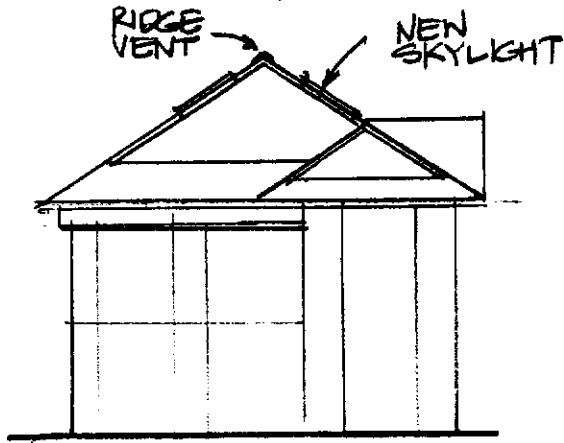
