**Title: Contract: Uniform Rental and Cleaning Services**

**Location/Council District:** Citywide

**Recommendation:** Adopt a **Resolution** 1) awarding a one-year contract with a one-year renewable option to Mission Linen and Uniform Service, the lowest responsive and responsible bidder, to provide uniform rental and cleaning services to the City in an amount not to exceed \$411,000; and 2) authorizing the City Manager or the City Manager's designee to execute the above contract and enter into such extension, provided that sufficient funds are available in the budget adopted for the applicable fiscal year(s).

**Description/Analysis:**

**Issue:** The City of Sacramento has a customer requirement to provide uniform rental and cleaning services for City personnel required to wear uniforms during the course of their daily work.

**Policy Considerations:** The recommendations in this report are in accordance with City Code Section 3.56. This type of service is covered under the prevailing wage ordinance by the City of Sacramento. Laundry services provided under this contract are subject to the Prevailing Wage Ordinance approved by the City Council on November 21, 2006. The City Council approved a prevailing wage rate of \$11.50 per hr., which includes fringe benefits for 2007, for laundry service contracts.

**Committee/Commission Action:** None

**Environmental Considerations:** Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 1537(b)(3).).

**Rationale for Recommendation:** In September of 2007, Procurement Services solicited bids for uniform rental and laundry services. These services are used by various departments to provide uniform rental and cleaning services for City personnel required to wear uniforms during the course of their daily work.

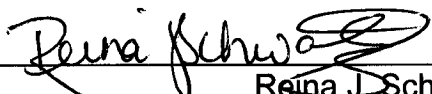
The Procurement Services Division has determined that Mission Linen and Uniform Service is the lowest responsive and responsible bidder based on pricing and cost submitted in response to bid no. B081181019 and as shown in Attachment 1.

As this service is subject to a prevailing wage rate, which is likely to increase each year over the potential two year term of this contract, an increased funding level is being requested based on anticipated annual cost increases.

**Financial Considerations:** Sufficient funds are available in the various departments operating budgets for purchases of this service. Uniform rental and cleaning services are subject to an annual increase in the prevailing wage rate paid to those employed as part of this contract. The contract may potentially be used for up to 2 years. Therefore, an inflationary factor of 4% per year, along with contingency cost of 10% has been estimated to more accurately reflect potential cost adjustments that may occur during the life of this contract. The table below includes these estimated factors in the totals projected during the term of this potential 2- year contract.

### **CONTRACT WITH MISSION LINEN AND UNIFORM SERVICE, TO PROVIDE UNIFORM RENTAL AND CLEANING SERVICES**

#### **BACKGROUND**

- A. The City of Sacramento has collective bargaining agreement requirements to provide uniform rental and cleaning services for those City personnel required to wear uniforms during the course of their daily work. This contract will serve over 622 personnel at one hundred and twenty-two locations around the City.
- B. On September 18, 2007, Procurement Service competitively advertised Invitation for Bid B081181019, for uniform rental and cleaning services. On October 3, 2007, the City received only two responses. Procurement Services performed an analysis of the bids received and determined that the bid submitted by Mission Linen and Uniform Service is the lowest responsive and responsible.

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. Award a one-year contract with a one-year renewal option to Mission Linen and Uniform Service, the lowest responsive and responsible bidder, for the purchase of uniform rental and cleaning services in an amount not to exceed \$411,000.00. Option may be exercised provided that sufficient funds are available in the budget adopted for the applicable fiscal year(s).
- Section 2. The City Manager or the City Manager's designee is authorized to execute the above contract and enter into such extension, provided that sufficient funds are available in the budget adopted for the applicable fiscal year(s).
