

MINUTES OF THE SPECIAL MEETING  
OF THE CIVIL SERVICE BOARD

Barbara Sueker, Typist Clerk III - Engineering Department, who would have been scheduled at 1:30, was out of town on vacation.


Sophie Joseph, Stenographer Clerk III - City Clerk Office, who would have been scheduled at 1:40, was sick.


