**SUBJECT:** Resolution Approving Negative Declaration for DEMOLITION  
OF STRUCTURE AT 1806 N STREET

SUMMARY:

The Environmental Coordinator has reviewed the subject project and finds that it will not have a significant adverse effect on the physical environment and therefore recommends that the project and a Negative Declaration be approved by the City Council.

BACKGROUND:

In accordance with State EIR Guidelines for Implementation of the California Environmental Quality Act of 1970, dated December 1976, an Initial Study was performed. As a result of this study, it was determined that the Demolition of Structure at 1806 N Street would not have a significant adverse effect on the physical environment and a draft Negative Declaration was prepared. On December 11, 1980 the Negative Declaration was filed with the County. On December 17, 1980 Notice of Opportunity for Public Review of the draft Negative Declaration was published in The Sacramento Union. The appropriate length of time has elapsed for receipt of comments regarding the Negative Declaration, with no comments having been received.

RECOMMENDATION:

The Environmental Coordinator recommends that the attached resolution be passed which will:

1. Determine that the proposed project will not have a significant effect on the environment.
2. Approve the Negative Declaration.

- 6a. The noise level of the area will temporarily increase during demolition.
- 12. The demolition of the structure will eliminate one residential structure.
- 20. The structure to be demolished is located in Preservation Area #10, and is a priority structure; however, the building, by reason of materials of construction, obsolescence, dilapidated condition, deterioration, damage, and electrical wiring, is in such condition as to be a fire hazard and danger to the public health and safety, and is so situated as to endanger life or other buildings or property in the vicinity and provide a fuel supply to augment the spread and intensity of fire arising from any cause. The building is unoccupied and open to transients or minors and, therefore, constitutes a serious fire and health hazard. In view of the above facts, the structure should be demolished to eliminate the public health and safety hazard.

IV. Mitigation measures proposed to minimize environmental impacts for the project as identified above. (Explain in detail - if none, so state)

Upon recommendation of the Historic Preservation Board, demolition is to be delayed for six months to allow time to find a potential developer who would be interested in renovating the structure.
