ALLOCATION OF MACHINIST HELPER
CLASS TO MONTHLY SALARY RANGE:

Recommendation made by the

Secretary that since the class

of Machinist Helper is not included in the contract between Machinist's Union and the Construction Industries, it should be removed from the hourly rate group and allocated to a 5-step monthly salary range effective January 1, 1964.

Communication from Ray Jones, Water Division Superintendent, dated November 12, 1963, recommending a salary range of \$440-525 for the class of Machinist Helper, was read and ordered filed.

After discussion, it was the order of the Board that action on this matter be laid over to the next regular meeting.

COMMUNICATION FROM CITY COUNCIL:
Salary recommendations for
January 1, 1964

Communication from Reginald Boggs,
City Clerk, dated November 14,
1963, advising that the City

Council is referring the matter of employees salary increase recommendations back to the Civil Service Board for determination as to whether all miscellaneous employees as well as uniform police and fire department employees should be considered for a full step salary increase effective January 1, 1964, was taken under consideration.

Mr. Kenneth Jones, President of the Sacramento City Employees' Association appeared before the Board and requested that consideration be given to a full step increase for all employees in place of the 1/2 step recommendation for the miscellaneous group, pointing out that surveys of private industry salaries indicate that salary rates in the state have been increasing in excess of 4% per year.

Secretary advised that at the time the salary recommendations were made to the Council in August 1963, 17 of 26 major California cities had granted salary increases or adjustments, but as of this date, 25 of the same 26 cities had granted salary increases or adjustments.

After discussion, motion was made by Mr. Erickson that the Civil Service Board amend the salary recommendations made in August and a new recommendation be made to provide for a one step increase for all employees effective January 1, 1964. There was no second to the motion.

It was the order of the Vice Chairman, Clarence Alexander, that the matter be laid over to the next regular meeting on November 26, 1963, for further consideration.

Laborer in the Park Department,


dated November 11, 1963, requesting an additional 90 day leave of absence from November 30, 1963, to February 27, 1964, because of illness, was considered.
