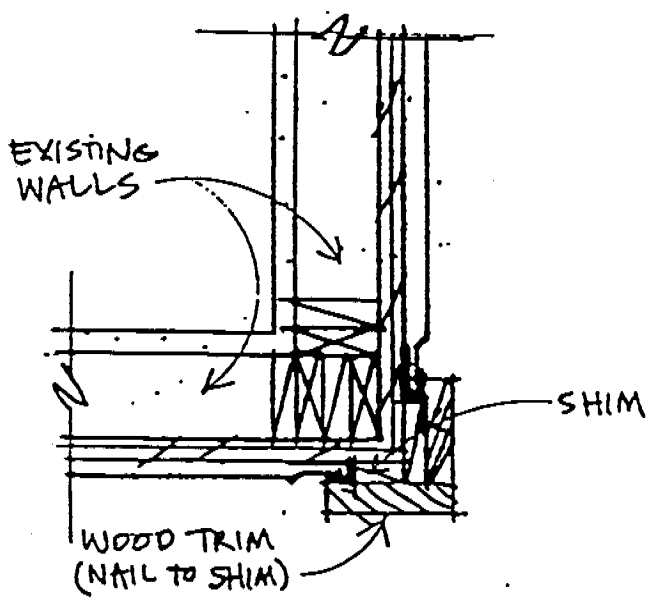

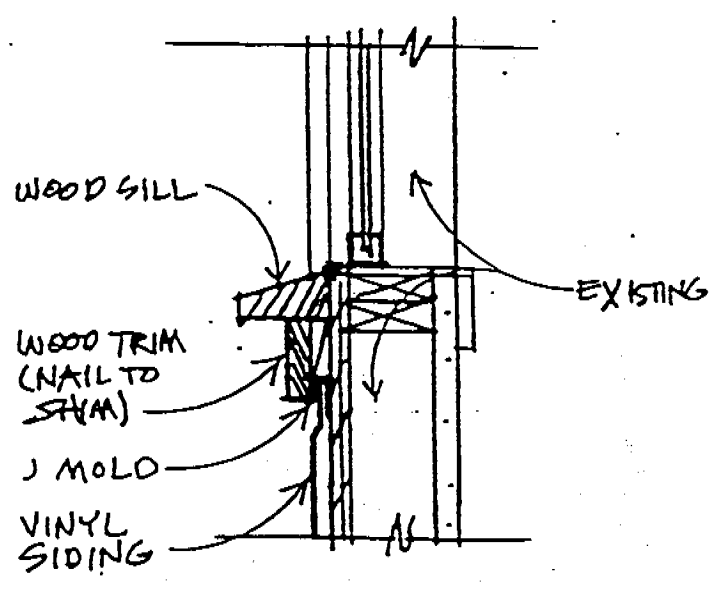
WINDOW ELEVATION
