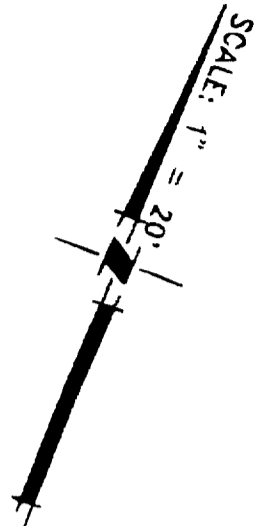
REMARKS

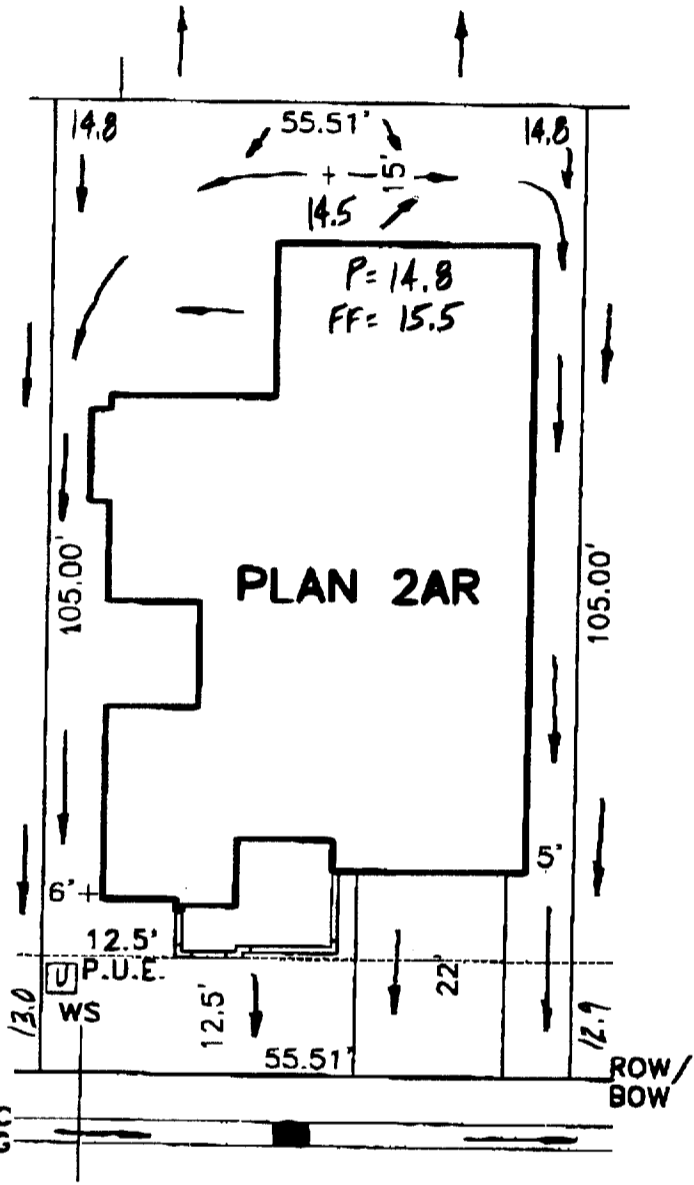
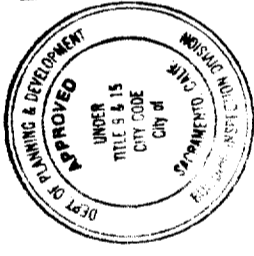
