SUMMARY


The attached report is being submitted to the Budget and Finance Committee for review and recommendations prior to consideration by the City Council at their regular meeting May 12, 1987.

SUMMARY

This report recommends that the City Council, by Resolution, authorize the City Manager to extend the Telos Consulting Services agreement for a consultant to supervise the Department of Data Management's Computer Operator staff. Said consultant agreement would be extended for a period of no more than two months for a cost not to exceed \$9,800. Total Agreement costs including the extension will not exceed \$22,800.

BACKGROUND

The Department's Computer Operator Supervisor resigned effective November 1, 1986. This position is responsible for supervising the Computer Operators that operate the City's mainframe computers, both the new IBM 4381 and the Sperry 90/80. They also maintain the tape library system and operations documentation. The work this staff performs requires careful planning and a thorough knowledge of both the computer and the production application software systems.

The City's Computer Operator staff is still very much in the learning stage on the new IBM computer and requires guidance and expertise by bringing in an outside consultant with all the skills we need for that position, we can keep our computer operating properly. This person could also share his/her skills with the existing staff.


FINANCIAL

Funds for this consultant for an amount not to exceed \$9,800 are available utilizing the savings in the Division's (1330) Maintenance and Repair (4241).
