

RESOLUTION NO. 2014-0258

GRANT: APPROVAL OF MEMORANDUMS OF AGREEMENT (MOAs) FOR PARTICIPATION IN CALIFORNIA TASK FORCE SEVEN (CA TF-7), URBAN SEARCH AND RESCUE (US&R) TEAM

BACKGROUND

- A. The City of Sacramento Fire Department has been the sponsoring agency for the CA TF-7 US&R Team since the inception of the Federal US&R program in the early 1990's. CA TF-7 has provided emergency assistance to many major incidents including the mudslide in Oso, Washington; the bombing of the Federal Murrah building in Oklahoma City; the terrorist attack of the World Trade Center in New York; the Gulf Coast in the aftermath of Hurricane Katrina; and various other events.
- B. Each year the City of Sacramento Fire Department, as a sponsoring agency, must submit an application for annual funding to receive monies to support the administrative requirements, training, equipment maintenance and/or purchases necessary in order to ensure Task Force readiness.
- C. The US&R Team, sponsored by the City of Sacramento, consists of personnel from the City of Sacramento Fire Department and other Participating Agencies. The Sacramento Fire Department, representing the City as the sponsoring agency, is responsible for maintaining adequate personnel on the US&R team. Other agencies and personnel are essential to accomplishing the task force goals including maintaining the specialized equipment cache, training task force personnel, and mobilizing the team upon activation.
- D. Current MOAs for nine Participating Agencies and nine Affiliated Personnel have been processed over the last five years.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager, or Fire Chief as his designee, is authorized to execute the MOA, attached as Exhibit A and made a part of this Resolution, with Michael Boyle for training and potential deployment to disasters per FEMA instruction.

Section 2. The City Manager, or Fire Chief as his designee, is authorized to execute the MOA, attached as Exhibit B and made a part of this Resolution, with Robert Patterson, Jr. for training and potential deployment to disasters per FEMA instruction.
