MINUTES OF REGULAR MEETING OF FEBRUARY 16, 1988

A motion was made to approve the minutes of the March 1, 1988 Civil Service Board meeting.

REPORTS OF DIRECTOR OF PERSONNEL

Ms. Donna Giles, Director of Personnel, informed the Board that she had no reports.

APPEAL OF JOSEPH B. DRAPER - PARKING ENFORCEMENT OFFICER - DISQUALIFICATION FROM TRAFFIC INVESTIGATOR EXAMINATION PROCESS

Ms. Stephanie Clymer, Personnel Analyst addressed the Board on this item. Ms. Clymer informed the Board that Mr. Draper was disqualified from taking the examination because he did not meeting the requirements or qualifications established for the examination. Ms. Clymer also informed the Board that Mr. Draper also cites improper procedure in the administration of the test. Since Mr. Draper did not participate in the test, staff feels that it is inappropriate for him to appeal under these grounds.

Ms. Giles and Mr. Carnazzo informed the Board that under Civil Service Rule 4.11(c)(7) the Board may make such orders to modify the procedure set forth for examination appeal hearings in individual cases.

A motion was made to waive the procedural requirement for hearing and proceed with the hearing as set forth in Civil Service Board Rule 4.11(c)(7).

After considerable discussion by the Board, Ms. Clymer, Mr. Draper and Ms. Silva a motion was made to deny the appeal of Joseph B. Draper's disqualification from the Traffic Investigator Examination process.

Ms. Bronda Silva, Senior Personnel Analyst, addressed the Board on this item. Ms. Silva informed the Board that this revision and retitling of the Systems Programmer classification and the addition of the Programmer I level is necessary because of the severe recruitment problems the department is having. The Systems Programmer I would be a training level position and will be responsible for performing less complex systems programming work under the general supervision of the new Systems Programmer II position.

A motion was made to revise and retitle the Systems Programmer classification and adding a Systems Programmer I level for first and second readings.


