SUBJECT: Annexation to Sacramento Regional County Sanitation District

SUMMARY

It is requested that the City Council approve the resolution allowing the Director of Public Works to request that the Sacramento Regional County Sanitation District (SRCSD) annex certain properties.

BACKGROUND

Some of the properties that are within the City limits lie outside the existing SRCSD services area but are within the District's sphere of influence. Section 5 of the Master Interagency agreement between SRCSD and the City of Sacramento provides that local sanitary sewer service may be provided to property outside the territorial jurisdiction of SRCSD after annexation to SRCSD has been effected. The agreement also provides that the City shall initiate such requests for annexation to SRCSD involving properties within the City limits. County Counsel has confirmed that the City may initiate such requests with a letter from the Public Works Director asking SRCSD to take all steps necessary to annex the described properties.






