

ORDINANCE NO. 971, FOURTH SERIES

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 498, FOURTH SERIES, PASSED JANUARY 15 1931, AND ENTITLED: "AN ORDINANCE DEFINING GARBAGE, RUBBISH AND WASTE MATTER AND PROVIDING FOR THE REGULATIONS, KEEPING, GATHERING, RECEIVING, DISPOSING AND DESTRUCTION THEREOF; PROVIDING FOR THE COLLECTION AND DISPOSITION THEREOF BY THE CITY OF SACRAMENTO; FIXING THE FEES TO BE PAID FOR SAID SERVICE; MAKING IT UNLAWFUL TO SPILL OR THROW GARBAGE, RUBBISH OR WASTE MATTER OF ANY KIND UPON THE STREETS, ALLEYS, PUBLIC PLACES OF VACANT LOTS OF THE CITY OF SACRAMENTO; PRESCRIBING THE HOURS WHEN THE BURNING OF RUBBISH MAY BE DONE WITHIN THE LIMITS OF THE CITY OF SACRAMENTO; MAKING A VIOLATION OF THE PROVISIONS OF THIS ORDINANCE A MISDEMEANOR, AND PROVIDING A PENALTY THEREFOR; REPEALING ORDINANCE NO. 17, 4TH SERIES, PASSED SEPTEMBER 22ND, 1921; ORDINANCE NO. 50 4TH SERIES, PASSED JANUARY 12TH, 1922; ORDINANCE NO. 57, 4TH SERIES, PASSED FEBRUARY 14TH, 1922; ORDINANCE NO. 82, 4TH SERIES, PASSED JUNE 29TH, 1922; ORDINANCE NO. 146, 4TH SERIES, PASSED JANUARY 24TH, 1924; ORDINANCE NO. 225, 4TH SERIES, PASSED JUNE 4TH, 1925; ORDINANCE NO. 344, 4TH SERIES, PASSED AUGUST 25TH, 1927; AND ORDINANCE NO. 466, FOURTH SERIES, PASSED APRIL 17, 1930." ADDING A NEW SECTION THERETO, TO BE NUMBERED 2 $\frac{1}{2}$, AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1. Section 1 of Ordinance No. 498, Fourth Series, passed January 15 1931, is hereby amended to read as follows:

SECTION 1. GARBAGE, as the said word is made use of in this Ordinance, consists of dead animals, of not more than ten pounds weight each, and of every accumulation of animal, vegetable and other matter that attend the preparation, consumption, decay, or dealing in, or storage of, meats, fish, fowl, birds, fruits, or vegetables. The term "garbage" does not include fish water or waste water.

RUBBISH, as the word is made use of in this Ordinance, consists of wood, leaves, dead trees, or the branches thereof, chips, shavings, sawdust, woodenware, dodgers, printed matter, paper, pasteboard, grass, rags, straw, boots, shoes, hats, and all other combustible matter not included in this Ordinance under the term "garbage".

WASTE MATTER, as the word is made use of in this Ordinance, consists of natural soil, earth, sand, clay, gravel, loam, manure, stones, bricks, brickbats, plaster, Portland cement, crockery, queensware, glass, glassware, ashes, cinders, shells, metals, tin cans, bottles, and all other non-combustible material.

SECTION 2. A new section is hereby added to said Ordinance No. 498, Fourth series, to be numbered 2 $\frac{1}{2}$.


SECTION 2½. Used tin cans must not be placed in the container with garbage, but must be kept in a separate container. Said container must be placed on the curb in front of the premises for collection not later than 6:00 A.M. on the 1st Sunday of each month, subject to change by the City Manager.

Where regular garbage service is rendered by the City of Sacramento, no extra charge shall be made for the removal of tin cans or bottles, but where tin cans or bottles alone are taken by the City Garbage Collector, the regular charge shall be made for such service; provided, however, that under no circumstances will an extra charge be made for the removal of prepared tin cans which are placed on the curb as hereinabove specified. All used tin cans set aside for collection must be prepared tin cans.

The term "prepared tin cans" as used in this section, means tin cans from which the contents have been emptied and the labels and ends removed; which have been thoroughly cleaned so as to remove all organic matter and have had their sides flattened.


SECTION 3. This ordinance is hereby declared to be an emergency measure and shall take effect immediately; such emergency being that the War Production Board issued an Order on October 20th 1942, requiring the salvage of all used tin cans. This order becomes effective as of November 4th 1942. An emergency exists in the United States because of the shortage of metals. There is a demand for all used tin cans available in the City of Sacramento for use in the recovery of copper by the precipitation method. Every ton of tin cans that is sent to a detinning plant to be prepared for such use replaces a ton of steel scrap which would otherwise have to be utilized for this purpose.
