REQUEST TO WAIVE RESIDENCY REQUIREMENT

Reference was made to a letter from Wayne G. Peyton, M.D., regarding the respiratory problems of Amanda Young, daughter of Firefighter Alan Young; this letter had been distributed to Board Members prior to the commencement of the meeting.

There was some discussion on this request, and Deputy Fire Chief Kenneth Feil informed the Board that the Fire Department had no problem with the response time from Firefighter Young's home in Auburn. Deputy Chief Feil also stated that Firefighter Young would reapply for this waiver on a regular basis, should his appeal be granted.

Mr. Bill Carnazzo, Deputy City Attorney, responded to Board's questions and informed that they did have the jurisdiction to grant this waiver of Rule 13.5(a).

There was some discussion on the differences between the two sets of findings of fact presented by each attorney and their relationship to the findings of the Administrative Law Judge. The Board also discussed with the two attorneys present, and with Mr. Bill Carnazzo, Deputy City Attorney some aspects of this issue, including the rigidity of General Order X5 and whether in the Board's opinion Officer Henriksen was negligent or not.

Motion was made to adopt Mr. Simmons' findings of fact and determination of issues.

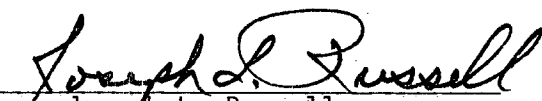

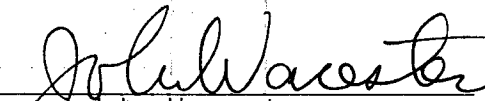
