MINUTES:

Doug Holmen, Associate Planner, stated there is a growing concern with the number of social service agencies and facilities developing throughout various neighborhoods in the City. Because of this concern, the City Planning Commission directed staff to prepare an expanded work program, which would include a social services distribution report and suggested policies for regulating location of future facilities.

Mr. Holmen stated that the City Planning Commission recommendations are as follows: 1) Facilities with fewer than six persons should not be researched or analyzed 2) Placing caps on facilities would not be appropriate 3) Focused studies of known problem type facilities would be beneficial to the City Council in reaching decisions on individual projects.

Committee member Kastanis responded that locational criteria for social service agencies need to be refined. He also suggested that the localization criteria be prioritized and the concentration issue be addressed more clearly.

Chair Robie stated there is not enough data provided in the staff report to make a conclusion and that staff needed to go back and analyze facilities with fewer than six clients. Ms. Robie also stated that group facilities should be categorized in order to identify impacts.

The following people provided testimony: Mary Erwin, President of Human Services Information Systems; Nancy Findeisen, Director of Human Services Information Systems.

The Committee directed staff to: 1) research those facilities with fewer than 6 persons and work with the Police Department to identify those that are unlicensed 2) report back to committee on program plan and budget 3) report back from City Attorney's office on the issue of placing caps on facilities.

MINUTES:

Mr. David Boggs, General Manager of Regional Transit, gave an oral status report. Mr. Boggs reported that Light Rail is currently carrying 10,500 riders per day. Thirty five percent of the riders are using the system during the off peak hours. Mr. Boggs also stated that a fourth car has been added to relieve the overcrowding problem during peak hours.

Mr. Boggs also gave highlights on the positive impacts Light Rail has offered to the City of Sacramento.
