The Civil Service Board met in special session in the office of the Board at 7:30 P.M.

Date of Appointment

Dr. Utt appeared before the Board stating that in 1921 he became ill with Bovine Tuberculosis, taking what he thought was

a leave of absence at that time. After being away for a month or so, he said that Commissioner Chas. A. Bliss requested his resignation in order that his position might be filled. He again commenced work for the City in August, 1922, 15 months after resigning in May, 1921, and was employed until November of 1922, then being unemployed until June, 1923, from which date he has been employed continuously by the City. Dr. Utt presented a letter from Mr. Bliss dated September 4, 1937 setting forth Mr. Bliss's impressions regarding this matter and a letter from Dr. Burt F. Howard dated September 8, 1937, also discussing the matter. A letter was also presented from Dr. Wm. K. Lindsay further discussing the question. After discussion the Board advised Dr. Utt that in accordance with the provisions of Rules and Regulations and due to his being absent for a period of more than one year from City service, it would be impossible for the Board to give him a date of appointment prior to June, 1923, but that due to Charter amendments and the fact that he had not missed more than three years, he still was eligible for retirement from the January, 1914 date of appointment.
