

RESOLUTION No. 2439

RESOLUTION OF PRELIMINARY DETERMINATION OF LEGISLATIVE BODY  
UNDER "SPECIAL ASSESSMENT INVESTIGATION, LIMITATION AND  
MAJORITY PROTEST ACT OF 1931" NO. 2439

BE IT RESOLVED by the City Council of the City of Sacramento that certain improvements are proposed to be done and made within the boundaries of the proposed assessment district hereinafter described.

In connection therewith, said City Council hereby finds and determines as follows; to-wit:

1. That the nature of the proposed improvement and the location and extent thereof consists of improving the ALLEY BETWEEN "K" AND "L" STREETS, from the easterly line of 17th Street, to the westerly line of 18th Street; by removing and disposing of all surplus and refuse material; installing cast iron gutter drains; reconstructing existing concrete manhole by placing curb and cover to grade; constructing vitrified ironstone pipe sewer; grading; and constructing an hydraulic concrete pavement six (6) inches in thickness.

2. The boundaries of the district of lands proposed to be specially assessed to pay the costs and expenses of such proposed work and improvement are generally defined as follows, to-wit:

West by 17th Street; north by "K" Street, from the easterly line of 17th Street to a point 40 feet west of the westerly line of 18th Street; thence southerly and parallel to the westerly line of 18th Street, a distance of 120 feet; thence easterly at right angles, to the westerly line of 18th Street; thence southerly on the westerly line of 18th Street, to a point 80 feet south of the southerly line of the alley between "K" and "L" Streets; thence westerly at right angles, to the easterly line of Lot 6 in the block bounded by "K" and "L" and 17th and 18th Streets; thence southerly on the easterly line of said Lot 6, to the northerly line of "L" Street; thence westerly on the northerly line of "L" Street, to the easterly line of 17th Street.

3. That the amount and portion of the cost of such proposed improvement proposed to be paid by the City of Sacramento from any source other than special assessments upon benefited property is nil.

4. The statute under which it is proposed to conduct proceedings for the proposed improvement is the "Improvement Act of 1911," approved April 7, 1911, and the several acts amendatory thereof or supplemental thereto; with bonds to be issued as authorized under the "Improvement Bond Act of 1915," approved June 11, 1915, and the several acts amendatory thereof or supplemental thereto, said bonds to bear interest at the rate of five (5%) per cent per annum; and

~~BE IT FURTHER RESOLVED that the City Engineer is hereby directed to prepare for this Council a written Report upon the proposed improvement, such Report to contain all the information required by Section 3 of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931," approved June 8, 1931, and the several acts amendatory thereof or supplemental thereto.~~






