MINUTES

FIRE ALARM OPERATOR'S EXAMINATION

Re: Regular Members of Fire Dept.

An oral examination was held for the Fire Alarm Operators to qualify them as regular members of the Fire Department.

Assisting in the examination were Chief Mulligan and Mr. H. H. Jaqueth. After some discussion with Mr. Jaqueth regarding the legal difficulty in making these men Uniform Firemen due to special charter requirements covering Uniform Firemen, it was decided that the naming of the examination would be left open until the Secretary could secure instructions from the City Attorney regarding any conflict with the provisions of the Charter and the regulations. HANS M. FRANDSEN
Reinstatement

A letter from Hans M. Frandsen stating that he had been in the Navy since December 14, 1942, and there-

fore wished to waive his name for appointment until after the war. Since Patrolman's Eligible Register No. 165 has been abolished in the meantime, it was moved by Mr. Deise, and seconded by Mr. Cavanaugh that Mr. Frandsen's name be restored to the Eligible Register in accordance with regulations governing men unable to accept certification because of military service.
