Freeport Boulevard Overlay from 4th Avenue to 11th Avenue (JN:1452) -SUBJECT:

Fund Appropriation

#### SUMMARY

This project has been advertised for bids. Bids have been received and appropriation of funds is necessary.

#### BACKGROUND

The section of Freeport Boulevard from 4th Avenue to 11th Avenue requires maintenance to prevent further damage to the street. Caltrans has entered into an agreement with the City to reimburse the cost of a petromat and overlay project up to the maximum of \$100,000. A categorical exemption was filed with the County on June 16, 1986.

On July 1, 1986 the City Council approved the plans and specifications for this project. Bids were received and opened by the City Clerk on July 22, 1986. The bids received were:

Teichert Construction	\$93,510
R.C. Collet, Inc.	\$98,600
Granite Construction Company	\$99,880

The engineer's estimated contract cost was \$92,000. Even though the low bid was 1.6% above the engineer's estimate, it is believed to be the best bid available at this time. The estimated project completion date is October 30. 1986.

#### FINANCIAL

No funds have been appropriated for this project. The estimated total project cost, including all planning, design and construction costs, is \$98,500. It is proposed that \$100,000 be appropriated from the Capital Grant Fund (248) which would be reimbursed when Caltrans reimburses the City.
