SUBJECT: REJECT ALL BIDS FOR THE BRIDGE RAIL REPLACEMENT AT THREE LOCATIONS PROJECT (PN:TM26)

LOCATION AND COUNCIL DISTRICT:

Elvas Avenue Overcrossings over H Street and J Street - Council District 3.
Sutterville Road Overhead over 24th Street - Council District 5.

RECOMMENDATION:

This report recommends City Council reject all bids for the Bridge Rail Replacement at Three Locations Project (PN: TM26).

SUMMARY:

Bids were received on October 16, 1996. The bids were considerably higher than engineer's estimate and funding is not available. The project will be re-bid in 1997.

BACKGROUND INFORMATION:

This project is part of the 1993/94 Federally Funded Bridge Rail Replacement Program.

This project was advertised and bids were received on October 16, 1996 and are summarized below:

This project will be re-bid at a later date.

FINANCIAL CONSIDERATIONS:

- The Engineer's estimate is \$248,000.
- As the low bid is considerably higher than available funding, rejection of all bids is recommended.
- This project will be re-bid in early 1997 and the bid period extended to allow more contractors an opportunity to bid. The City will negotiate with Caltrans to increase the federal obligation to cover a greater portion of the project cost, if necessary.

ENVIRONMENTAL CONSIDERATIONS:

On September 11, 1996, a Categorical Exemption was filed with the County Clerk for the Bridge Rail Replacement at Three Locations project.


