Staff has reviewed the proposed project, and approves it with the following conditions of approval:

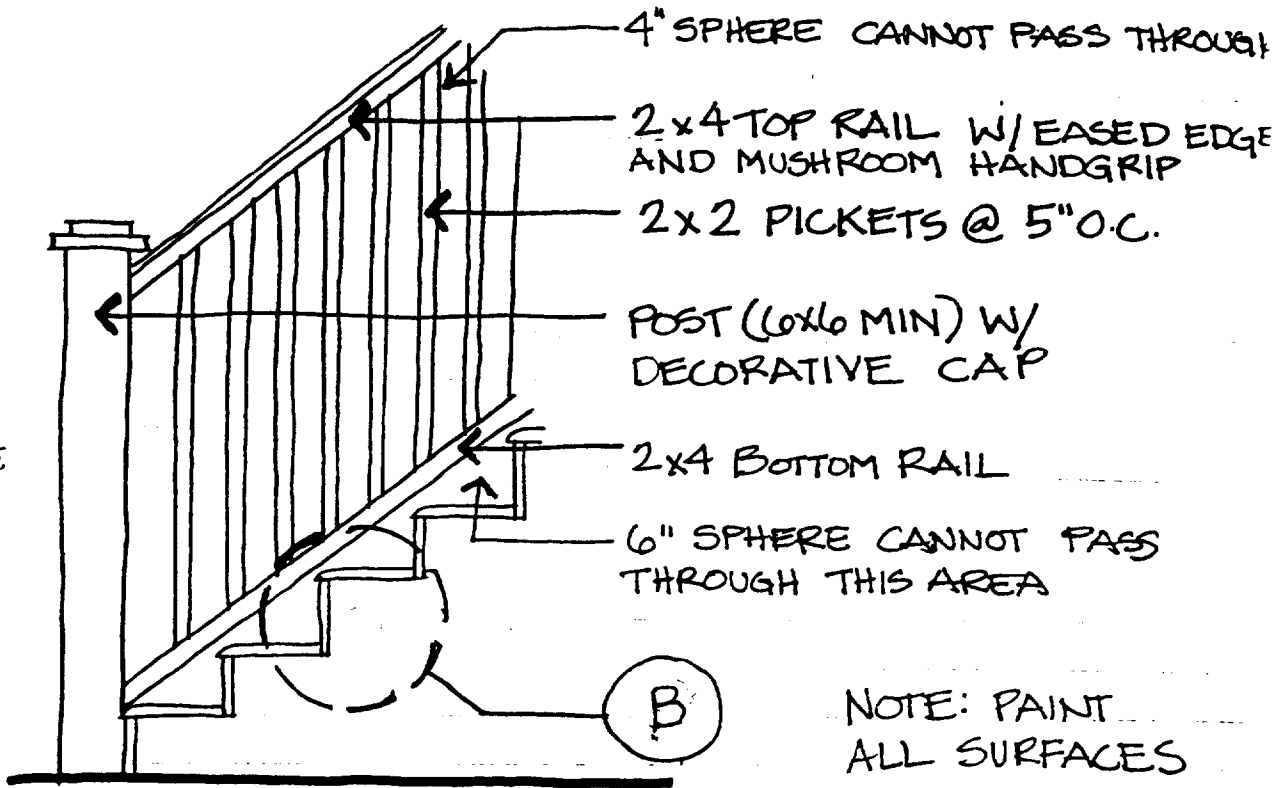
1. Provide decorative newel post and railings at front porch stair per attached details. Paint to match existing trim color.

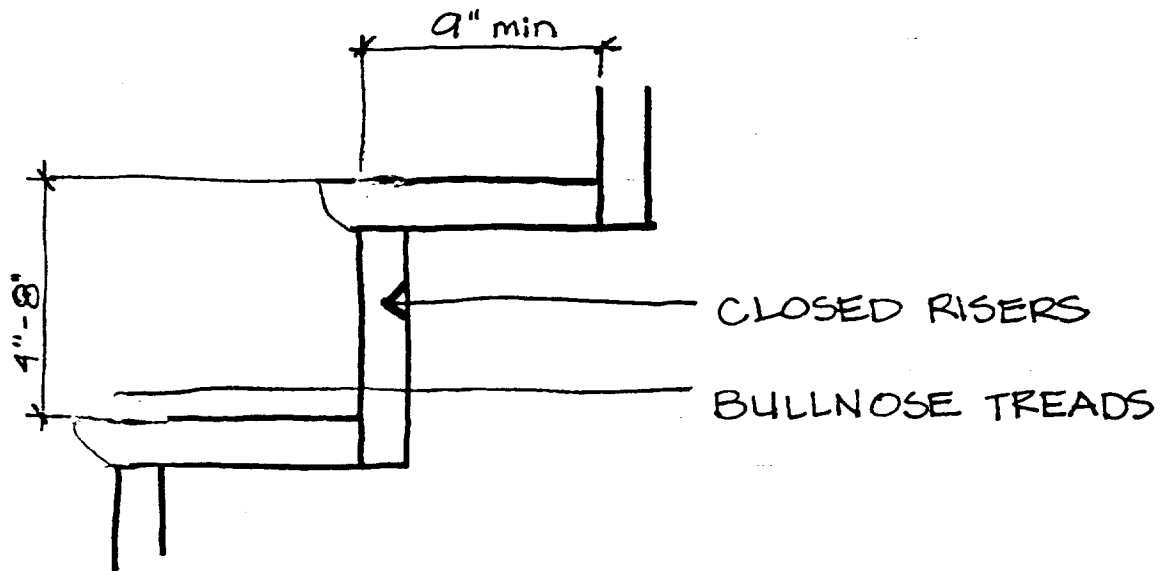
