Pursuant to Call of Chair, and notice served upon each member of the Council of the City of Sacramento, the City Council met in Special Session on this date at hour of 11:25 A. M., Mayor Elkus presiding and Roll Call being answered by following members of the Council:

Anderson, Bidwell, Brown, Elkus, Goddard, Kiernan, John H. Miller.  
ABSENT: Frazier, Royal Miller.

Call for the Meeting, declaring same to be for the purpose of receiving Budget for Year 1925, was read and ordered filed.

Report of the City Manager transmitting, in accordance with Section 74 of the City Charter, the Budget recommendations for the Fiscal Year ending December 31st, 1925, was read and copies furnished members of the Council.

City Manager also submitted Roster of City Employees per Resolution No. 170. Copies of Budget having been furnished and after general discussion by all

members of Council, Councilman Kiernan moved that the Budget be received and placed on file. Seconded by Mayor Elkus and carried by following vote:

Councilman Goddard addressed Council stating that members should make a thorough study of Budget recommendations before criticisms and agreements are made, during Special or Regular Meetings and thereupon moved that consideration of Budget be made a Special Order of business at Regular Meeting to be held on date of September 18, 1924, at 9 o'clock P. M. Seconded by Councilman Bidwell and matter was discussed by all members of Council after which Councilman Goddard with consent of Second withdrew foregoing motion.
