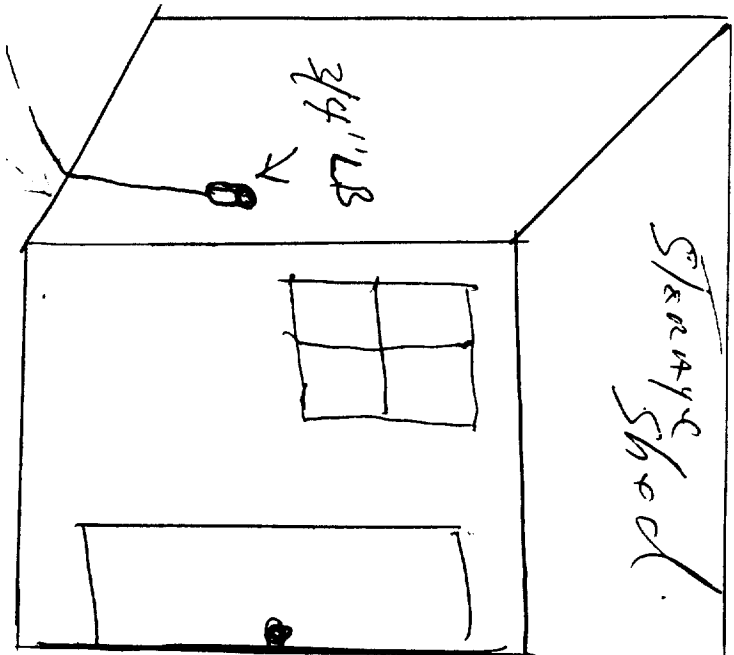


Rear of House 71 45th Street
