

ORDINANCE NO. 1224, FOURTH SERIES.

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 1202, FOURTH SERIES, PASSED AUGUST 30, 1946, AND ENTITLED: "AN ORDINANCE REGULATING THE CONSTRUCTION OF WATER MAINS IN SUBDIVISIONS WHICH ARE NOT NOW SUPPLIED WITH WATER AND MAKING THIS AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY," BY ADDING A NEW SUBDIVISION THERETO TO BE KNOWN AS SUBDIVISION (o), AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

WHEREAS, prior to August 30, 1946, several homes and dwellings were in the process of being constructed in subdivisions outside of the City Limits of Sacramento which are furnished with water through a water distribution system owned by the City of Sacramento; and

WHEREAS, the plumbing, water pipes and connections in these houses were being constructed according to the general usage and type of construction prevailing in these subdivisions outside of the City of Sacramento,

BE IT THEREFORE ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:


SECTION 1: Section 1 of Ordinance No. 1202, Fourth Series, passed August 30, 1946, is hereby amended by adding a new subdivision thereto to be known as Subdivision (o):

(o) The Plumbing Inspector of the City of Sacramento may grant permits approving plumbing and water service connections to the City Water Distribution System for all houses and dwellings upon which construction had actually started and was proceeding prior to August 30, 1946, which, in his opinion, substantially complies with the plumbing and water regulations and will not in his opinion be a menace to health or be detrimental to the water distribution system: The burden of proving that the applicant's house was actually started prior to August 30, 1946, shall be upon the applicant and proof of exemption from the strict provisions of Ordinance No. 1202, Fourth Series, shall be subject to the discretion of the Plumbing Inspector of the City of Sacramento and the directions that he may give to make the proposed applicant's plumbing and water system substantially comply with the provisions of Ordinance No. 1202, Fourth Series.

SECTION 2: This ordinance is hereby declared to be an emergency measure and shall take effect immediately; such emergency being to allow houses in process of construction prior to August 30, 1946, in subdivisions outside of the City of Sacramento, to connect with water mains upon showing of substantial compliance, thereby preventing hardship to said owners.
