

Sacramento, California,

October 20, 1931.

The Civil Service Board of the City of Sacramento met in special session on the above date at seven o'clock P. M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman, and Chenu.
ABSENT : None.

The reading of minutes of the following meetings were read and approved as read: August 10th, August 28th, August 31st, September 4th, September 16, and October 5, 1931.

The records of Mr. J. Spencer's application for examination as Garbageman was reviewed by the Board. Mr. Spencer was in attendance and his Personal Fitness test was reviewed to determine whether or not any error had been made on the part of the Board in his original examination. After an examination of Mr. Spencer by the individual members of the Board, it was properly moved by Commissioner Weisman, seconded by Commissioner Maloney, and unanimously carried, that the records as originally recorded were correct.

The records of Mr. Harry Elebeck's application for examination as Garbageman was reviewed by the Board. His Personal Fitness test was reviewed to determine whether or not any error had been made on the part of the Board in his original examination. After reviewing his record, it was properly moved by Commissioner Weisman, seconded by Commissioner Maloney, and unanimously carried, that the records as originally recorded were correct.

Mr. Adam Stringer, a candidate in the examination for Garbageman and claiming preference under Section 45 of the City Charter,

left his discharge papers with the Board and after a review of same by the Board it was properly moved by Commissioner Maloney, seconded by Commissioner Weisman, and unanimously carried that the discharge was in order and that he be granted preference under this section.

At this time Commissioner Maloney retired from the meeting at eight-fifteen o'clock P. M.

It was properly moved by Commissioner Weisman, and seconded by Commissioner Chenu that the examination for Junior Clerk be held Saturday afternoon, November 14, 1931, at one-thirty o'clock P. M., at the Sutter Junior High School. The vote was as follows:


AYES: Commissioners Weisman and Chenu.
 NOES: None. ABSENT: Commissioner Maloney.

The examination for Junior Clerk as prepared by the Secretary was accepted with the addition of a typing test to be held for fifteen minutes, and a minimum of thirty-five words per minute with not more than ten errors, be considered a passing grade.

The service record of John Gubel was reviewed. Upon motion by Commissioner Weisman, seconded by Commissioner Chenu, the Secretary was instructed to investigate this case and, if possible, secure the resignation which the employee himself tendered the department in which he worked.

No further business appearing before the meeting, they stood adjourned at nine thirty-five o'clock P. M. to meet again at the call of the Chair.
