MINUTES OF CIVIL SERVICE BOARD  
 CITY OF SACRAMENTO  
 SPECIAL MEETING

November 13, 1941

The Civil Service Board met in special session in their office at 7:30 P.M.

PRESENT: Commissioners Cavanaugh, Deise and Stacy  
 ABSENT: None

ENGINEERING AID EX. #157  
 Personal Interviews

At this time the Board interviewed those  
 candidates who had successfully passed  
 the written examination. Following the

interviews, percentages were determined and upon agreement, the Secretary was

instructed to prepare and post a Tentative Eligible Register.

RULES AND REGULATIONS

Amendments

After discussing an amendment to the Rules and Regulations to provide for employees and eligibles who are call-

ed into military service during periods of National Emergency, Dr. Stacy moved that RULE VIII be amended by adding Section 5 as follows:

RULE IV Section 4. TERMS OF ELIGIBILITY (Add the following)

When an eligible register is abolished, eligibles unable to accept employment or continue employment because of military service during a period of national emergency, may have their names placed on the top of the new list if their names have been reached in certifications to permanent or to temporary positions, if they so request and submit their honorable discharge papers within 90 days after release from military service.

Those eligibles whose names were not reached by certification, and who were unable to take the new examination because of military service, may have their names placed on the new list at their old percentage, if they so request and submit their honorable discharge papers within 90 days after release from military service.

RULE VIII Section 5. MILITARY LEAVES (Add the following section)

When employees are called or volunteer for emergency military training, they may be granted a leave of absence for the duration of service by the Civil Service Board. Any such employee, upon presentation of his honorable discharge within 90 days from the expiration of his training, shall be reinstated to his former position. He shall not lose seniority because of absence in such military service. If the employee was employed from an eligible list to a position of a temporary nature, and the position was abolished prior to his return to duty, his name shall be returned to the eligible list in accordance with his percentage on such list.

ED A. WACHENFELD

Request for Reinstatement

At this time Mr. Wachenfeld appeared before the Board and requested that because of a disability in-

curring in line of duty which prevented him from obtaining other employment, the Board reinstate him to his former position. Mr. Wachenfeld was informed that because of the City Attorney's opinion, this would not be possible and was advised to see the City Manager's office concerning any injury incurred in line of duty.

PROBATIONARY PERIOD  
COMPLETED

The Secretary presented a list of seven Park Department employees who had cumulated six months service partly in the Park Department and partly in the Engineering Department. Dr. Stacy moved that according to the Civil Service rules, Messrs. Ernest Cervantes, Andi Gaddi, Howard L. Laux, Albert G. Yeager, Vernon Thompson, Joseph F. Houk and Jesse F. Webster be deemed as having completed their six months probationary period; seconded by Mr. Cavanaugh and unanimously carried.

SALARY SCALES

Health Dept. Employees

After reviewing the salary information considered at the October 8, 1941 meeting relating to the salary scales of Health Department Inspectors, Mr. Cavanaugh moved that the Board report such findings, and the Civil Service Board recommends that due to the long and conscientious service, the City Council consider increasing the salary of the four employees with over seventeen years service; seconded by Dr. Stacy and unanimously carried.


