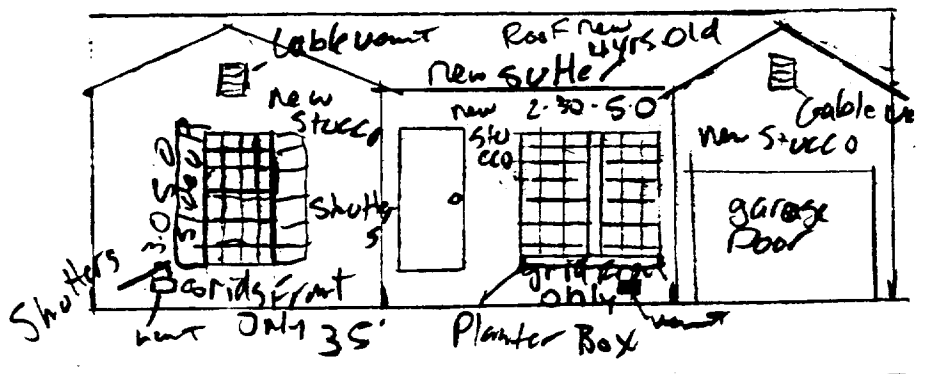

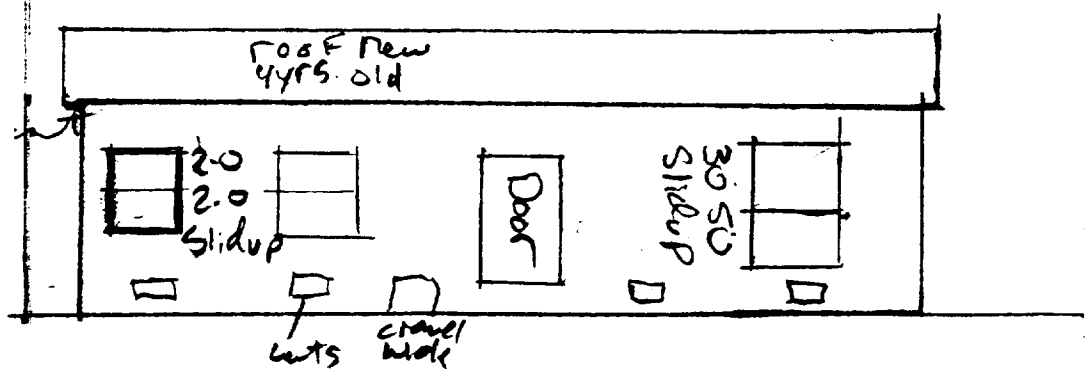
FRONT Elevation

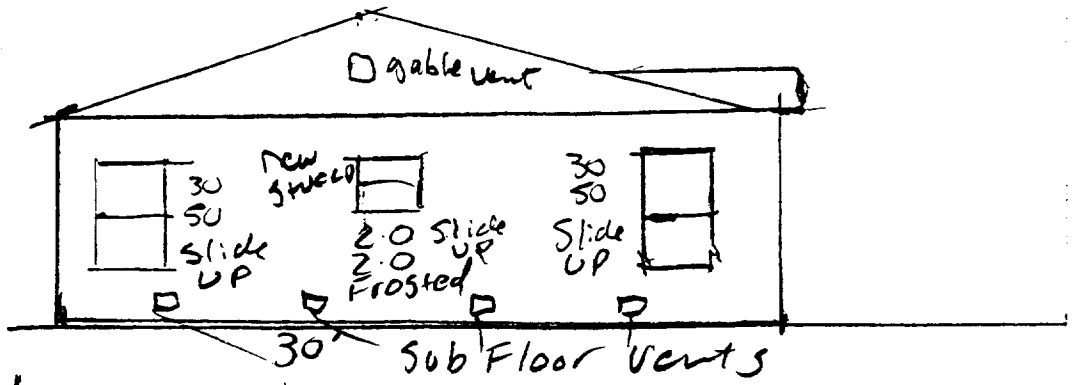

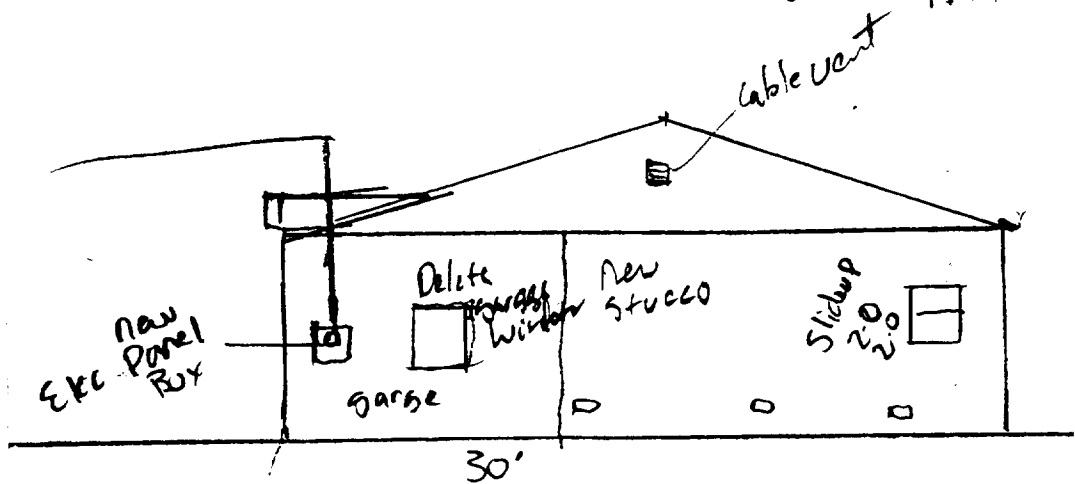
