SUBJECT: Revocable Encroachment Permit - Lewis & Haarmeyer

SUMMARY:

On August 21, 1979, the City Council, by passage of Resolution No. 79-564, approved Lewis & Haarmeyer's request for a revocable permit to use the hollow space under the sidewalk for storage and restrooms. The area for which this request was made is adjacent to County Assessor's Parcel No. 006-012-32, 12' x 76', at 114-120 I Street.

The City Council recently authorized a study of the hollow sidewalks in the downtown area. During the course of this study, the consultant indicated that the area under the hollow sidewalk at the subject location could be potentially hazardous. Therefore, it is staff's opinion that the permit should be revoked. The property owner was informed of our intent to request the revocation by letter on August 5, 1981.

RECOMMENDATION:

The City Engineer recommends that Resolution No. 79-564, adopted August 21, 1979, granting a revocable permit to Lewis & Haarmeyer for the purpose stated above be revoked by passage of the attached resolution.
