


RESOLUTION NO. 3264 DIRECTING THE SUPERINTENDENT OF STREETS TO NOTIFY PROPERTY OWNERS TO CONSTRUCT SIDEWALKS ON PORTIONS OF D STREET BETWEEN 41ST STREET AND LA PURISSIMA WAY, AND FIXING THE DAY, HOUR AND PLACE OF HEARING OBJECTIONS THERETO.

RESOLVED, that pursuant to Division 7, Part 3, Chapter 27 of the Streets and Highways Code of the State of California, the Superintendent of Streets is hereby directed to notify property owners to construct concrete cement sidewalks, as required by the City of Sacramento Standard Specifications, on the North side of D Street between 41st Street and La Purissima Way, and South side of D Street between 42nd Street and La Purissima Way, as shown on the plan attached hereto and made a part hereof, in those blocks where over 50% of the sidewalks have heretofore been constructed; and

BE IT FURTHER RESOLVED that the hour of 7:30 o'clock p. m., on the 29th day of May, 1958, in the Council Chamber of the City Council of the City of Sacramento in the City Hall on I Street, between 9th and 10th Streets in said City, is hereby affixed as the day, place and time for Hearing of objections or protests, if any, and show cause why the proposed work and improvement shall not be carried out in accordance with this Resolution.
